Report from Jayleigh

Jayleigh summarized her responsibilities, with the caveat that her role is still a "work in progress." She is currently working with 3 advisors, including Jen Guillemin, to help identify areas of focus and priorities, including:

- Religious Exploration (RE) for children & youth, and for adults
- Adult RE is currently less structured than the children's RE
- Community involvement through events in the First Parish immediate vicinity and in the wider inter-religious community.

Jayleigh will be at First Parish throughout the Summer. Jayleigh requested that the Board keep her informed of candidates as the board works through the Interim Minister search process

Report from Erin

Erin confided that she had felt hurt and misled because she has not been invited to our 2022-23 Board meetings to date. This was the first time Board members had heard this request, and some of us expressed surprise and dismay that we did not realize the Ministerial Intern should be included in our Board meetings. Erin cited the following needs going forward:

- <u>Jen</u> is the point person for Jayleigh, at least through June, but there was a question whether Jen would continue this role after the end of her Board term in June.
